Permission Update

Should you wish to **WITHDRAW** your permission for any clause then place a cross in the box in the particular section, please leave the boxes blank if you are happy for your child to have permission for these.

Emergency treatment declaration

In the event of an accident or emergency involving my child I understand that every effort will be made to contact me immediately. Emergency services will be called as necessary and I understand my child may be taken to hospital accompanied by the setting manager (or deputy) for emergency treatment and that health professionals are responsible for any decisions on medical treatment in my absence.

- Evidence of activity and achievement

Photos/videos are stored on the setting's computer only; we only store images during the period your child is with us.
